## GENERAL RULES & NOTES

- 1) The sale of bottled water and soda will not be allowed. These items will be sold exclusively by VAAR.
- 2) You must follow Wake County Health Department's food safety guidelines posted at [www.wakegov.com/food/festivals/Pages/default.aspx](http://www.wakegov.com/food/festivals/Pages/default.aspx).
- 3) **All food vendors must attend an information session on food safety guidelines organized by VAAR. Booth registration is automatically rejected if you do not attend the information session. VAAR will send the date, time and place of the food safety information session to all vendors through email once we have that information available.**
- 4) VAAR reserves the right to reject the sale or display of any offensive items including sexual, religiously fanatic or pro-communist materials.
- 5) Food and non-food booth dimensions are 10'x10' and 8'x10', respectively; each booth is equipped with two chairs and one 8' table (non-food booth) or two 8' tables (food booth).
- 6) Booth fee includes one electrical outlet, if needed. Please contact VAAR if additional outlets are required (\$25 extra charge for each additional outlet).
- 7) No open flames or gas appliances are permitted in the building.
- 8) Each non-food booth will get two free admission passes and each food booth will get three admission passes. Additional booth personnel will need to buy tickets at the gate or vendors can pre-purchase volunteer tickets through VAAR at a discount. This rule will be strictly enforced by State Fairgrounds staff.
- 9) **Registration form and check (payable to VAAR) must be received by 11:59 PM, January 12, 2020.** Mailing address: **VAAR**, PO Box 41163, Raleigh, NC 27629. The form can also be sent by email to [contact@VietRaleigh.org](mailto:contact@VietRaleigh.org) by the same deadline.
- 10) **Spaces are limited**, so your timely response is essential. Submitting the application does not mean you will automatically have a booth assignment. Booth will be accepted and assigned based on the order in which applications are received and space availability at that time.
- 11) VAAR will assign booth locations and will inform all vendors by telephone and/or email on or before Friday, January 24, 2020.
- 12) To decorate the booth, prepare the food and get ready for the general public:
  - a. vendors of the day-time event are allowed to access the building starting at 5:00 PM (Jan 25) and 8:00 AM (Jan 26).
  - b. vendors of the night-time event are allowed to access the building starting at 3:00 PM (Jan 26).
