- 2) VAAR reserves the right to reject the sale or display of any offensive items including sexual, religiously fanatic or pro-communist materials.
- 3) Food and non-food booth dimensions are 10'x10' and 8'x10', respectively; each booth is equipped with two chairs and one 8' table (non-food booth) or two 8' tables (food booth).
- 4) Booth fee includes one electrical outlet, if needed. Please contact VAAR if additional outlets are required (\$25 extra charge for each additional outlet).
- 5) No open flames or gas appliances are permitted in the building.
- 6) Each non-food booth will get two free admission passes and each food booth will get three admission passes. Additional booth personnel will need to buy tickets at the gate or vendors can pre-purchase volunteer tickets through VAAR at a discount (maximum 5 discounted tickets per nonfood booth and 10 discounted tickets per food booth). This rule will be strictly enforced by State Fairgrounds staff.
- 7) Registration form and check (payable to VAAR) must be received by 11:59 PM, December 17, 2023. Mailing address: VAAR, PO Box 41163, Raleigh, NC 27629. The form can also be sent by email to both of these addresses: hung-vaar@outlook.com and justin.nguyen.nc@gmail.com by the same deadline.
- 8) Your timely response is essential. Due to limited space, each individual or organization is allowed to register for one booth. If you have a need for two booths, you can request for it and we wil review your needs. Submitting the application does not mean you will automatically have a booth assignment. Applications will be accepted and booths will be assigned based on the order in which applications are received and space availability at that time.
- 9) VAAR will assign booth locations and will inform all vendors by telephone and/or email on or before Friday, January 19, 2024.
- 10) To decorate the booth, prepare the food and get ready for the general public:
 - a. vendors of the day-time event are allowed to access the building starting at 5:00 PM (Jan 20) and 8:00 AM (Jan 21).
 - b. vendors of the night-time event are allowed to access the building starting at 3:00 PM (Jan 21).
